Program Descriptions and Presenter Biographies

New York State Court of Appeals Tour and Presentation

Biography: Frances Murray, a graduate of University College Dublin and the Law School of the Law Society of Ireland, is a solicitor (attorney) admitted to practice in the Republic of Ireland. Initially, she worked in the field of trusts and estates and later was a lawyer in the legal department of a leading London bank. While in London, she graduated from the University College London post-graduate program in Public International Law. While her husband was a graduate student at RPI, Frances had the opportunity to see an early version of Lexis, and it inspired her to enroll in SUNYA's library science program. She also studied database development at Drexel University and was employed by Lexis (Philadelphia) to train judges and lawyers in the use of the new database system. Graduating from the SUNY MLS program, Frances worked for the New York State Legislative Library and then became Library Director at the New York Court of Appeals. She was admitted to the New York bar and became Chief Legal Reference Attorney at the Court. She specializes in legal research and database development, and is expert in common law research.

Biography: Marissa Mason is enrolled in the M.S. Information Science/M.A. English joint degree program at the University at Albany and holds a B.A. in English and Writing from the College of Saint Rose. Her professional interests include digital archives, special collections and promoting the preservation of our cultural heritage. As a library clerical assistant at the New York Court of Appeals, she has participated in the development of Court-PASS, the Court's online Public Access and Search System. She recently returned from Scotland, where she completed a documentation and digital preservation project relating to theatrical performances at the Edinburgh Festival Fringe, an endeavor supported by the Women in Technology Award grant from the Initiatives for Women foundation.

Reporting New York's Common Law: The Law Reporting Bureau, the State Reporter and Official Publication of New York Court Opinions

Description: The presentation will include a brief history of the Law Reporting Bureau, the agency of the Court of Appeals charged with editing and supervising publication of the Official Reports in print and electronic formats; the responsibilities of the State Reporter, who heads the Law Reporting Bureau; and a discussion of the selection and publication processes.

Biography: William J. Hooks was appointed the 26th State Reporter by the Court of Appeals, effective June 25, 2009. A native of Brooklyn, Mr. Hooks is a graduate of Le Moyne College and Albany Law School and was admitted to the New York Bar in 1980. He joined the Law Reporting Bureau in 1981 as a legal editor, and served as Assistant State Reporter and Deputy Reporter prior to his appointment as State Reporter. Mr. Hooks is a member of the New York State Bar Association's Intellectual Property Section, President of the Association of Reporters of Judicial Decisions, and has served on the Board of Regents of Le Moyne College. He has participated in the presentation of a number of continuing legal education courses, including: The Selection of Opinions for the Miscellaneous Reports; An Introduction to the New York Reports, Third Series; Use of the Official Reports Style Manual, 2002 and 2007 Editions; Preparation of Opinions for Publication in the Official Reports, 2005 through 2012; and an Annual Survey of Attorney Disciplinary Proceedings, 2004-05 through 2011-12.

Forensic Medicine in a Pre-Scientific Age

Description: In brief, the talk examines the demand from courts of law for expert medical testimony and the capacity of the medical profession to satisfy those demands from antiquity to the early modern period. The talk reviews physicians' ability to accurately assess medical evidence during the Graeco-Roman period; in the middle-ages when the Graeco-Roman medical tradition disappeared in the West; and in the revival of that tradition during the renaissance. The revolution in experimental medicine that transformed medicine from a scholarly tradition into a science closes the review.

Biography: Christopher Hoolihan was born, raised and educated in Buffalo, N.Y., receiving his master's degree in library science (with a specialization in rare books) from SUNY Buffalo in 1977. He was Rare Book Librarian at Washington University School of Medicine Library in St. Louis from 1978 to 1985, and from 1985 to the present has been Rare Books & Manuscripts Librarian at the Edward G. Miner Library of the University of Rochester Medical Center. (He was also head of technical services at the Miner Library from 1993 to 2003.) Hoolihan has lectured and published on such topics as the transmission of Graeco-Roman medical texts from the late classical period to the Renaissance; 18th-century obstetrics; the illustration of 19th-century medical and surgical texts; the therapeutic use of wine; and 19th-century American popular medicine.

NELLCO at 30: Still Collaborating After All These Years

Description: NELLCO, an international consortium of law libraries, was founded in New England in 1983. For 30 years, members have collaborated to share the risks and rewards of implementing innovative ideas. From a grant to fund the installation of fax machines in the 80s, to a union catalog on CD-ROM in the 90s, to a decade of expansion in the 00s, and now to the Annual NELLCO Symposium and PALMPrint (Preserving America's Legal Materials in Print) in the 10's, come and find out what we're up to. Do you have any great ideas for library collaboration? Share them with attendees during this session.

Biography: Tracy L. Thompson has served as the Executive Director of NELLCO since 2001. In that capacity she works on behalf of 120+ law libraries throughout the U.S., Canada, the U.K. and Australia. Tracy facilitates the mission of NELLCO by seeking out and exploiting opportunities for members to collaborate. Prior to joining NELLCO Tracy served as International Reference Librarian for the Lillian Goldman Law Library at Yale Law School. She holds a B.A. from the University of South Florida (1994) and a J.D. from Yale Law School (1997).

Subpoenas for Secrets: The Story of the Belfast Project and the Need for Archival Privilege

Description: When interviewers began gathering oral histories from paramilitaries involved in Northern Ireland's Troubles, no one could have anticipated that a subpoena for those interviews would lead to a fight for access that would make it all the way to the Supreme Court. As the dust settles, academics, archivists, librarians, and their institutions are left to wonder—can this happen again? What protections can be offered to donors? Should the legal process win out over preservation of the historical record? Is archival privilege the answer? In an instance where the past is all too fresh, the legal situation surrounding the Belfast Project is not an anomaly, but rather a foreshadowing of what is to come.

Biography: Christine Anne George works at the Charles B. Sears Law Library at SUNY Buffalo Law School where she serves as a faculty services and reference librarian and oversees the law library's archives. Her article "Archives Beyond the Pale: Negotiating Legal and Ethical Entanglements after the Belfast Project" is available in the most recent issue of the *American Archivist* and on SSRN. She received her B.A. from Bard College, her J.D. from St. John's University School of Law, and her M.S.I.S. from the University of Texas at Austin School of Information. She has processed collections at the New-York Historical Society and worked with special collections as a Tarlton Fellow at the University of Texas School of Law's Tarlton Law Library.

New York State Library Tour and Presentation

Biography: Nancy Horan has been a Reference Librarian at the New York State Library for over 25 years, specializing in law and legislative reference. In recent years, she has also provided reference services for researchers using materials in the Manuscripts and Special Collections division of the State Library. Nancy graduated from Mount Holyoke College where she majored in French, spending her junior year studying at the Sorbonne in Paris. She earned her Masters in Library Science from the State University of New York at Albany. Prior to working for the State Library, she was employed for several years by the Ohio State University College of Law Library.

Biography: Cara Janowsky is an Associate Librarian in the Public Services Unit of the New York State Library and oversees the Library's Reference and Circulation/Stack Services Units. She coordinates and manages space planning activities for the Library and has planned and managed projects to consolidate and move over half of the Library's 20 million item collection. Ms. Janowsky also coordinates collection development activities in science, medicine and business. In addition, she began coordinating collection development activities for the social sciences, including law, in July 2012.

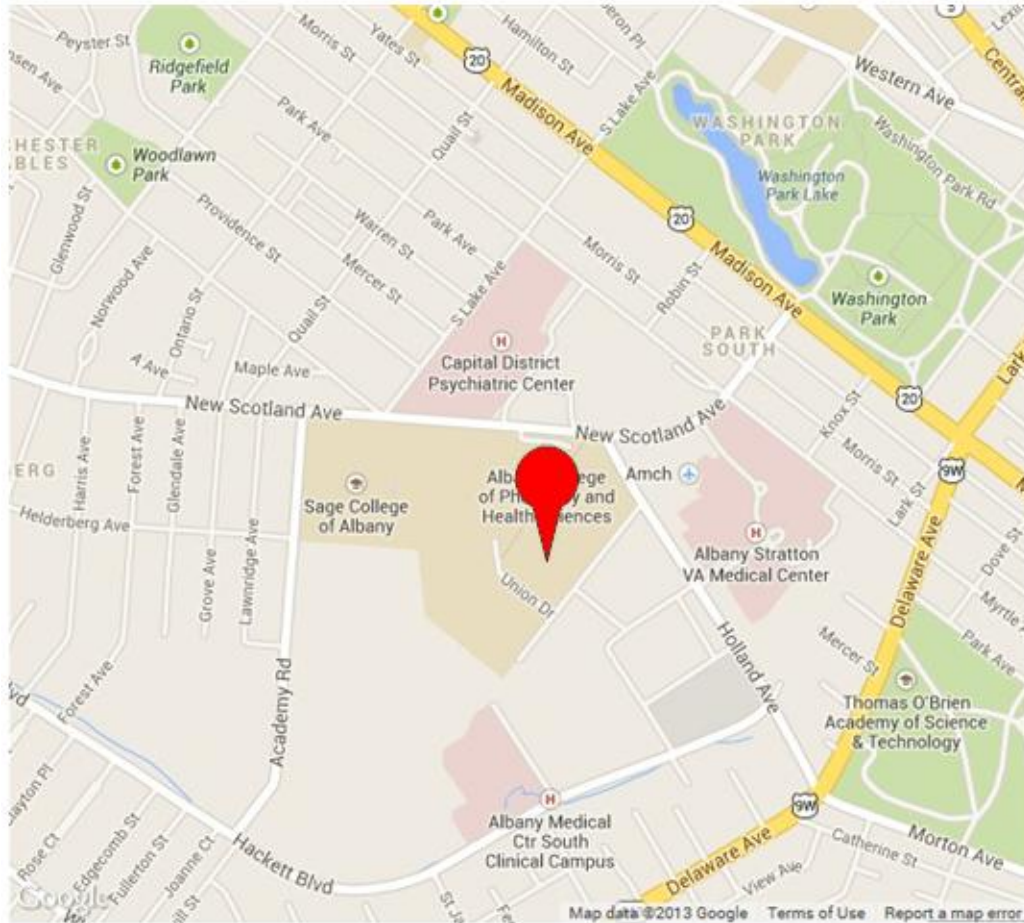
