Knowledge Mosaic

Patricia Barbone, Director of Library Services at Hughes, Hubbard & Reed LLP will be speaking with Dr. Schwartz on Securities Mosaic.

Peter Schwartz is Founder and President of Knowledge Mosaic LLC. In his presentation, *The Mountain and the River: Changing Perspectives on Legal Research and Legal Practice in the Age of Facebook*, Dr. Schwartz will emphasize the transition from an event-driven legal research environment (the mountain) to a process-driven environment (the river) and discuss how these research changes will actually drive profound changes in what it means to practice law. He will use illustrations from Securities Mosaic and SM Litigator.
