Administrative Oversight 75%--Reporting directly to the Dean of the Law Center, the Assistant Dean and Director is the chief administrative officer for the law library and information technology services and is responsible for all operations within both areas, including planning, budgeting, and administration. The Assistant Dean and Director monitors both the library and IT services to ensure that all programs and functions of each fully support the academic, research, and practical needs of Law Center students, faculty, and visitors. This position presents an opportunity for a creative administrator to help the Law Center enhance the library and information technology environments and an opportunity to work with the Dean to fill vacancies as they arise.

**Legal Research and Teaching 15%--** Under our current Legal Research and Writing program, the Assistant Dean and Director coordinates the research component of the required first year course in Legal Research and Writing and teaches in the program along with other members of the Library professional staff. In consultation with the Dean and faculty, there may be opportunities to teach legal research courses at both the introductory and advanced levels.

**Strategic Planning and Implementation 10%--**The Assistant Dean and Director works with the Dean and other members of the Law Center and LSU community to help determine the overall course and direction of the Law Center.

Significant administrative experience in a law library and understanding of the functioning and operation of an academic law school library.
