Carrots, cucumbers, alfalfa sprouts, avocado, onions, olives, roasted bell peppers, tomato, lettuce and cheddar cheese with dijon mustard on pumpernickel bread

- Caesar Chicken Wrap**
Marinated chicken breast with parmesan cheese, croutons, lettuce and Caesar dressing

Creamy pesto spread with roasted deli chicken, bacon, alfalfa sprouts, avocado, swiss cheese, lettuce and tomato

Tossed salad with turkey, grated provolone cheese and hard boiled egg
