## Reading on the Run

At least one book or magazine accompanies me to most meetings or on trips—especially airplane trips. Balancing the weight and bulk of the reading materials with my required packing creates challenges. For instance, I really enjoy this 700-page hard back book, but I'm more than half way through it and will surely finish it before my return. Not an Earth-shattering dilemma by any means. Still, the choice reduces or increases overall stress and back strain.

While reading one of my many librarian e-newsletters I found a reference to a new e-book reader for Blackberries and Treos. This intrigued me because I almost always have my Treo with me, so I wouldn't have to buy another electronic device. (I've resisted the dedicated e-book readers because of the Federal Aviation Administration requirement to turn them off during the first and last 10 minutes of airplane flights.) The software is free, and the Denver Public Library has circulating e-books.

So, relatively quickly and easily I installed Mobilpocket Reader, registered as an e-book user with the library, and downloaded my first book for my Treo. Next, I adjusted the font so I can read it without my reading glasses and practiced "turning pages" with a click.

Now, when I must ride light rail and there's standing-room only, I easily hold a hand strap and click through the pages while whisking to and from work. I still have to carry something else to read during the first and last 10 minutes of an airplane flight, but not nearly as much bulk. (Incidentally, there are also pictures of my new granddaughter, Lorelei Elizabeth Deuel, in my Treo.)

Carrying reading material once stood me in good stead during a job interview. The interviewer remarked at my forethought of bringing something to read instead of relying on the reading materials in his reception area. I got the job, too.
