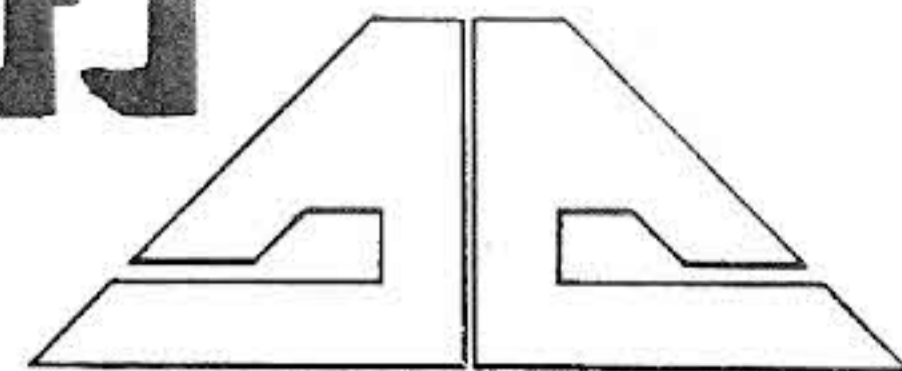

The State, Court and County Law Libraries Section is a special interest section of the American Association of Law Libraries which has as its purpose the improvement of the quality and services of its members' libraries and the promotion of the mutual interests of those libraries. A subscription to the NEWSLETTER costs non-members \$5.00 a year (2 issues: Fall and Spring). Previous issues of the NEWSLETTER were entitled SCLL NEWSLETTERv. 1-4.; a limited number of back issues are available at \$2.50 per copy.

The State, Court and County Law Library SIS had a fine year. It was a year of realignment and study; a year to set the pace for the 80's.

Two hundred eighteen persons joined the SIS this year. Thirty-one volunteered and were assigned to serve on committees. There is an opportunity for more members to participate in section activities.

The Nominations Committee, chaired by James Werner, reviewed the membership and nominated Edgar J. Bellefontaine, Director of the Social Law Library of Boston, for the position of Vice-Chairperson/Chairperson Elect; Linda E. Schneider, U.S. Court of Appeals, 3rd Circuit Branch, Pittsburgh, for the position of Secretary-Treasurer, and Pamela Gregory, Circuit Court for Prince George County Library (Md.), for the executive board position.

The Constitution and By-Laws Committee, chaired by Richard Beer, reviewed the constitution and reported that no change is necessary at this time. They do recommend review of the SCCLL constitution and by-laws after a new AALL Constitution is adopted.

The Statistics Committee, chaired by Joel Fishman, has explored ways of analyzing the data received on the annual questionnaire. He will report his findings and solicit comments at the annual business meeting.

The Program Committee, chaired by Mike Miller, planned a very worthwhile program. Sal Constabile will speak on time management. About 10% of our membership were surveyed to help Sal make this a relevant presentation. Vernon E. Palmour will discuss user surveys and community analysis. The local arrangements committee, chaired by Sue Welsh, has planned an enjoyable luncheon.

The Standards Committee, chaired by Carol Meyer, decided that the various standards needed no revision this year. A discussion of the future direction of this committee will be held at the annual business meeting.

Anita Shew, Editor and Chairman of the NEWSLETTER Committee, not only published two issues of the SCCLL NEWSLETTER, but also wrote a brief Procedures Manual. This manual will be helpful to future NEWSLETTER editors.

The AALL Executive Board has made many recent decisions which will benefit SCCLL-SIS - the most noteworthy are Saturday meeting times and profit making activities. The opening of Saturday prior to the annual meeting for other than the CONELL program will allow SCCLL to again use this day for programming. Jim Werner is planning the 1982 meeting for this day.

A discussion of possible revenue-producing projects will be held at the annual meeting.


