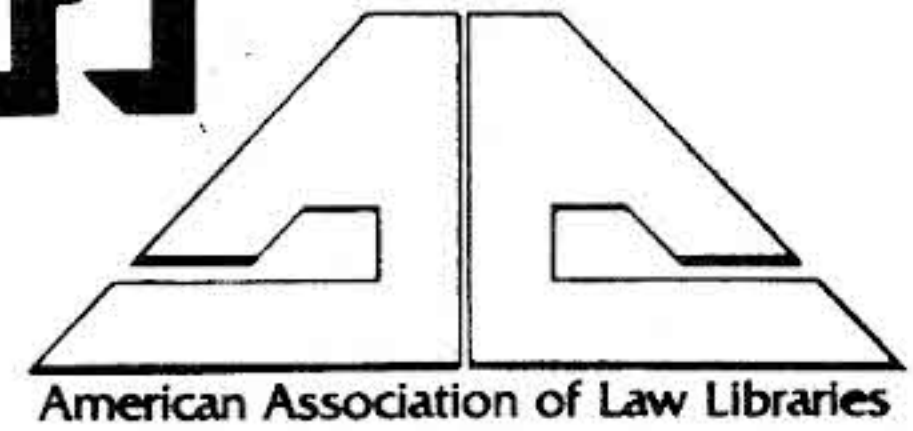

"'Fools Rush In . . .': Outreach services in publicly-funded law libraries" is the subject of the program which SCCLL will present on Wednesday, July 10 from 2:30 to 4:30 p.m. as part of the AALL New York meeting. Beth Peterson, of the Minnesota State Law Library, has organized the session. The panelists, who are all SCCLL members, will describe and discuss several extension services now being offered by state, court, and county law libraries.

Moderator Marvin Anderson, of the Minnesota State Law Library, will introduce the subject, speaking about the mission of publicly-funded law libraries to reach out not only to the legal profession, but also to government agencies and the general public. "Making Friends: Forming a Law Library Friends' Group" will be explained by Carol Billings, of the Law Library of Louisiana. Beth Peterson will discuss the Minnesota model for "Law Library Service to Prisoners." "County Coordination in Connecticut" will be the topic of Larry Cheseman, of the Connecticut State Law Library at Hartford. Mike Miller, of the Maryland State Law Library, will serve as commentator.
