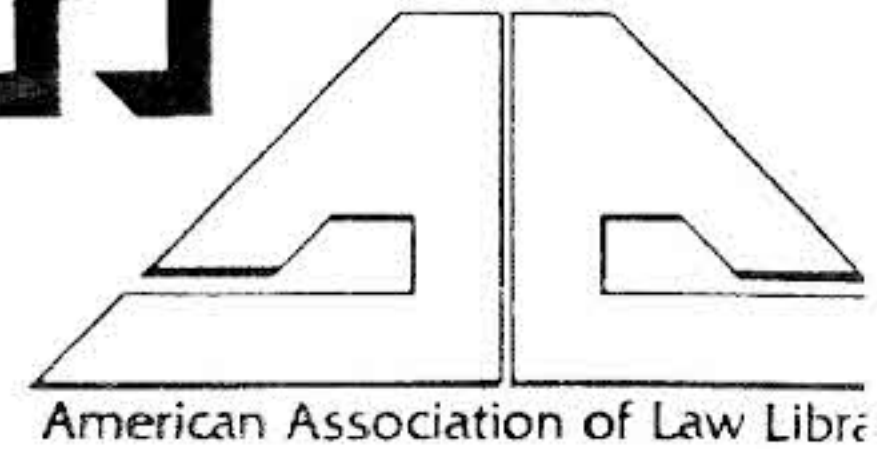

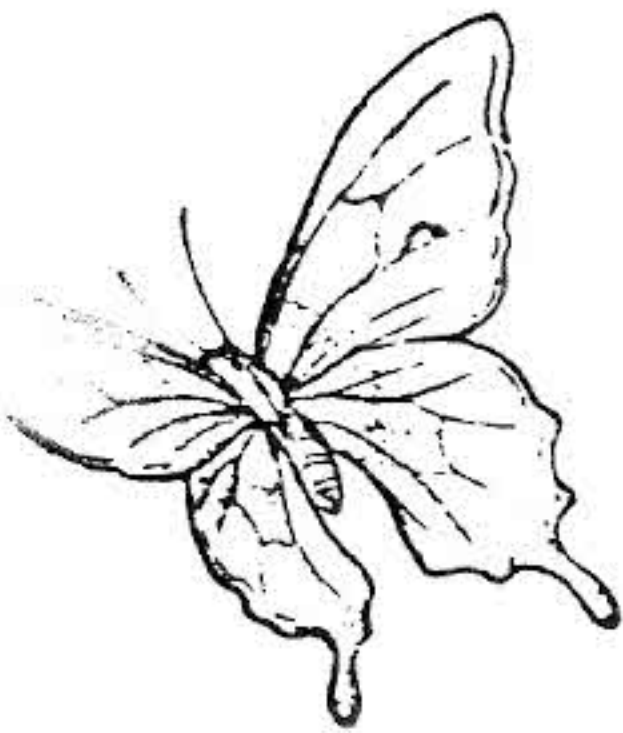

SPRING INTO ACTION !



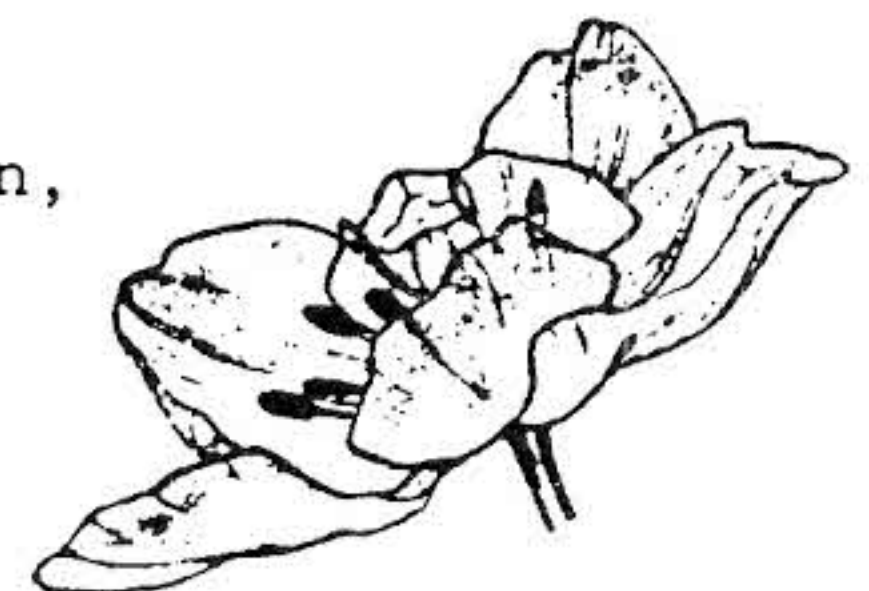
Because SCCLL is by far the smallest of the three type-of-library special interest sections in AALL, we sometimes need to make a special effort to have our interests represented. My last chairman's letter urged SCCLL members to volunteer for 1988/89 AALL committees. Already we have seen evidence of the Executive Board's sensitivity to our concerns in two recent actions. At its January meeting the Board appointed Gayle Webb, of the Riverside County California Law Library to the national Nominations Committee. To encourage representation of the broad spectrum of interests in our association, the Board adopted a resolution urging SIS's and chapters to establish formal procedures for bringing the names of potential candidates to the attention of the Nominations Committee.

Consequently, I have appointed a special SCCLL Committee for National Nominations, consisting of three distinguished past presidents of AALL: Jacquelyn Jurkins, chair; Connie Bolden; and Francis Gates, who direct county, state, and federal libraries respectively. Of course, Gayle Webb has encouraged SCCLL members who wish to use the suggestion form on page 5 for submitting any AALL member's name directly to the national committee. I would urge those of you who have in mind fellow SCCLL members to send your recommendations--or copies of them if you prefer--to our special committee so that they will carry the added impact of coming from the SIS.

Our special committee has also been charged to seek out worthy prospects and to establish their willingness to run for national office. From having had the pleasure of working with many talented, committed SCCLL members, I know that our ranks are rich with colleagues who deserve recognition and have a great deal to contribute to AALL.

Because the next SCCLL Newsletter will reach you rather close to the Atlanta convention, I want to urge you now to make arrangements to participate in the SCCLL annual meeting
