## SCCLL to have prominent role in 1991 Winter Institute

---

AALL's 1991 Winter Institute should have special appeal for members of the SCCLL SIS. At its November 5th meeting in Chicago, the AALL Executive Board approved a proposal from the Education Committee that the institute topic be Law Libraries—Serving the Legal Information Needs of a Varied Constituency: The Judiciary, the Bar, and the Public.

The proposal, written by Carol Billings, immediate past Chair of SCCLL and who is also on the Education Committee, outlines a

tentative list of topics to be covered and suggests categories of speakers. Although designed to answer particular needs of public, court and bar law librarians the program will be informative and beneficial for academic and law firm librarians as well.

Special emphasis is placed on access to information issues by various kinds of library users. Representatives of constituencies which use law libraries will form an important part of the faculty. These include judges, judicial administrators, government agency personnel, bar library board members, and citizens with specific social concerns. Of course, AALL members from court, bar, government, academic and firm libraries will address issues with which they are particularly concerned.

Although a date and location has not yet been set, early January and a balmy climate have become traditional for the Winter Institute.

In submitting the proposal, Carol emphasized that members of SCCLL would be urged to contribute to the planning of the program and to suggest faculty members. A future SCCLL NEWSLETTER will give greater details and will include a form for submitting suggestions.

A preliminary draft of the program suggests a keynote address on the subject of access to information in a democratic society. At the opening session a panel representing user groups will express their expectations of law librarians and take a position on whether our mission to serve is communicated effectively. A series of sessions would address: serving the judiciary, serving the practicing bar, serving the public, and extension of services to outlying areas.

Other parts of the program might include ethical and professional considerations in providing law library service to various constituents; special administrative problems in government-supported and subscription

libraries; cooperating with other libraries in the community; automation for improved service; and the implications of government information policy for law library users.
