PROPOSED BYLAW AMENDMENT

To be voted on at the annual meeting in Reno.

WHEREAS, the Secretary-Treasurer of the State Court and County Law Libraries' Special Interest Section of the American Association of Law Libraries currently serves a one year term; and

WHEREAS, continuity in this office would benefit the Special Interest Section through better record keeping; and

WHEREAS, both the Secretary and Treasurer of the American Association of Law Libraries are elected triennially;

NOW THEREFORE BE IT

RESOLVED, that Article VI, Section 3, C. of the Bylaws of the State Court and County Law Libraries' Special Interest Section Adopted June 25, 1977 and Amended July 2, 1979, June 24, 1980 and June 26, 1988 shall be amended to read as follows (deleted portions in brackets, added portions underlined):

Secretary-Treasurer. Shall serve for [one year] three years and shall record the minutes of the meetings, keep the records of the organization, including the financial records, give a written account of the funds of the Section when called upon to do so, and prepare such documents as directed by the Chairperson.
