SCCLL MEMBERS' IDEAS WANTED FOR 1991 AALL WINTER INSTITUTE

AALL's winter 1991 institute, "Law Libraries--Serving the Legal Information Needs of a Varied Constituency: the Judiciary, the Bar and the Public," has already sparked keen interest among SCCLL members. An informal straw poll conducted by institute co-directors Carol Billings and Ken Svengalis at the SCCLL annual meeting in Reno produced a list of 85 members who hope to be able to attend.

The institute is scheduled for Wednesday, January 30 through Sunday, February 3, 1991, at the Colonial Williamsburg Conference Center. Erick Lowe, Head Librarian of the nearby National Center for State Courts, and Jim Heller, Director of the Marshall-Wythe Law School library, also located near the Conference Center, are providing much assistance in the planning of this event.

The co-directors of the institute would like SCCLL members to send them suggestions for topics and speakers to be included. Some being considered are: 1) determining and meeting the needs of specific constituencies 2) extending law library services to unserved areas 3) ethical considerations, i.e. charging fees, determining how much assistance is appropriate, etc. 4) administrative problems: finances, personnel, relationships with governing bodies, politics, public relations 5) cooperation with other libraries and institutions 6) automation 7) the impact of government and publishers' policies on our institutions.

Arrangements will be made to give institute participants an opportunity to experience the delightful ambiance of Williamsburg through tours of historic buildings, plantations, etc. We will keep you posted on what promises to be a memorable event.
