## CHANGE OF ADDRESS

For those of you who haven't found out through the grapevine, this is an Official Announcement that I have changed my address, my city, and my type of law library! In December I relocate to Washington D.C. to become White House Law Librarian. Although the early arrival of cherry blossoms has been replaced by some March snow, I'm enjoying my new post. located in the gorgeous Old Executive Office Building, the Law Library has been recently restored to it's original 1888 grandeur. The Law Library is built of treated cast iron, and features a mosaic tiled floor and a covered ceiling with skylight. Nineteenth Century features (adjustable shelves and a hand operated booklet) complement modern innovations (on-line databases, catalog and circulation system).

One of three newly renamed Executive Offices of the President Libraries, the Law Library serves the staff of many E.O.P. agencies. Patrons frequently come from the following agencies, the White House Office, the Office of the Vice President, the Office of Management and Budget, the National Security Council, and the Council of Economic Advisers. The legal collection includes extensive federal administrative and congressional material, and an expanding collection of treatises and legal periodicals.

## Supreme Judicial Court Historical Society Established

In 1992 the Supreme Judicial Court of Massachusetts will celebrate its 300th anniversary. Not only has the Court's jurisdiction been exercised without interruption since 1692, it has never been without an incumbent justice, even during the Revolution. No court in the United States, or the Western Hemisphere for that matter, can boast so long a continuous existence.

With the authorization and encouragement of the full Court, the Supreme Judicial Court Historical Society was established by the Social Law Library in January of 1990 to assist in the commemoration of this anniversary. The Society will develop and coordinate anniversary activities with and for scholars, the bar, and the general public. What is Massachusetts' only organization devoted to the preservation of legal history, the Society will continue its work beyond 1992 by developing and supporting continuing programs that foster scholarly understanding and further public appreciation of the Supreme Judicial Court's unsurpassed history and its unique contributions to the state and the nation.

The Social Law Library has been designated the Society's parent organization. Chief Justice Liacos serves as the Society's honorary President, and the Justices of the Supreme Judicial Court as honorary Members. A Board of Overseers has been appointed by Chief Justice Liacos. The Board has been organized to set the society's objectives, outline its operating and fiscal policies, and recruit membership under the guidance of former Chief Justice Edward F. Hennessey. Librarian Edgar J. Bellefontaine is director of the organization.
