SEATTLE IN REVIEW

SCCLL Executive Board Meeting Abbreviated Minutes

Saturday, July 9, 1994, Seattle, Washington
Kathy Carlson

Meeting was called to order by Chair Anita Shew.

Present were: Anita Shew, Karlye Pillai, Anne Matthewman, Beverly Rubenstein, Charles Dyer, Gail Warren, Regina Smith, Pam Gregory, Jean Holcomb, Marvin Anderson, Deborah Norwood, and Kathy Carlson.

The meeting began with a presentation by Marvin as to the details of the planned SCCLL Sunday, July 10, 1994 meeting.

Kathy Carlson arrived and presented the minutes from the 1993 Executive Board Meeting held on Sunday, July 11, 1993 in Boston, Massachusetts. Regina Smith moved to accept the minutes. The motion carried.

Kathy Carlson presented the financial report. She explained that there was an audit conducted by headquarters last fall which showed an increase of available funding for SCCLL. After talking to headquarters, she made the decision to accept the statement and proceed on the assumption that it was correct. She asked that the report be approved. The Executive Board approved the report.

Kathy also presented proposed budget for July 1994-June 1995. The Executive Board approved the budget.

Anita Shew presented the Chair's Report. She referred to her complete written report which had been mailed to the Board members and asked that it be incorporated into the minutes. She did report that she had requested written committee reports from all committees and will present the report at the Sunday business meeting if a committee chair could not be present.

Other Business

There was a short discussion of the issue regarding more educational time for SIS programming. No conclusions were reached other than there should be a continuing effort to have more slots for the "big 3" (SCCLL, ALL, & PLL) since everyone falls into one of these groups. There was some speculation as to how the 1995 meeting will be structured given the addition of the National Conference on Legal Information Issues to the meeting.

There was a discussion of the proposed AALL dues increase and whether or not SCCLL should take an announced position. It was decided not to take a stand but to encourage the members of SCCLL to read the information provided, to attend the business meeting, and to vote as they felt was appropriate.

Anita asked Kathy to put a volunteer sheet out at registration Sunday morning to try to recruit people to staff the SCCLL table in the exhibits area.

Having no other business, the meeting was adjourned.
