BOSTON SCCLL PROGRAM

Members met at the Social Law Library in Boston for their annual Section meeting and were distracted from the heat by gracious hosts Edgar Bellefontaine and Maria Sekula and their historic library. The general program began with James McMillan, Director, Court Technology Laboratory, National Center for State Courts giving an overview of the technology required for networking in the courts. SCCLL member Kathy Welker gave a nuts and bolts lesson on her start-up experience of CD-ROM networking in the federal courts. A summary of her presentation is in this newsletter.

After the general program, 16 roundtable discussions were held. Topics were:

13. Electronic bulletin boards for SCCLL libraries

16. Budgeting for access, not ownership

The program and roundtables were planned by Vice-Chair Anita Shew and the Education Committee. Boston meeting attendees received a registration packet including all 16 roundtable 1-page outlines and bibliographies. A few

copies of these are left and are available from Maria Sekula at the Social Law Library. Program reviews from some of the roundtables are in this newsletter.

SCCLL EXECUTIVE BOARD MEETING

The SCCLL Executive Board comprising incoming and outgoing members met Sunday July 11 in Boston after the general SCCLL meeting and program. The following items were discussed.

- 1992/93 Chair Pam Gregory summarized her year's goal to increase visibility of SCCLL member libraries within the judicial community and within AALL. SCCLL members attended and participated in ABA/JAD meetings, National Conference on State Law Libraries, National Conference of Chief Justices and Court Administrators.
- Charles Dyer was recognized for his work on the Trustees Manual which will be published in the Fall.
- The high cost of the Newsletter and choice of printer was a major topic; possibilities included a generous offer from Hein Co. The Board was awaiting a quote from AALL headquarters before making a decision.
- The Board approved accepting advertising for the Newsletter. The Editors are drafting an advertising and editorial policy.
- Concern was expressed about the Newsletter publication schedule and the Board is looking at modification of the current times.
- The budget was a great concern. Because of the high cost of producing the Newsletter last year, the balance is very low. Projections for next year with lower Newsletter cost were promising.
- Two-year committee appointments were discussed. The Board voted to make only Standards and Statistics 2-year. Other committees may have members who wish to be reappointed to a second year to continue their interest or finish a project.
- 1993/94 Chair Anita Shew announced that she is preparing Section Procedure Manual.
