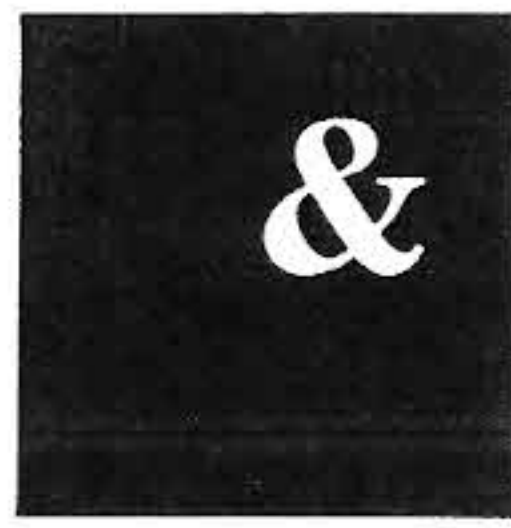

While not an AALL sponsored event, the State, Court and County section was in such full attendance at the November 12-14th Conference on State Court Libraries in Columbus, Ohio that we held a mid-year board meeting for the first time in the history of the section. The press release from that conference is attached (see page 5), as evidence of its relevance to all that the section will become in the years ahead. This watershed event is the start, finally, of a true dialogue between librarians and court administrators, judges and our boards of trustees. The role of
