At the October 2006 JSC meeting,
there was tentative agreement to
allow abbreviation of units of
measurement (5JSC/M/111.4.3).

3.1.5.1 Record *online resource* as the
carrier type for all online resources
(see 3.3).

3.1.5.2 For an online resource that is
complete (or if the total extent is
known), record the extent (see 3.4).

3.4.0.3.1 Record the extent of the resource by giving the number of physical units and an appropriate term for the type of carrier as listed under 3.3.0.2.

...focus [is] on the use of identifiers, names, and descriptions to refer to resources that are related to the resource being described.
