COME TO HOUSTON!

At the Annual Meeting in Houston, Texas, the Academic Law Libraries SIS is presenting Publications: The What, Where, Why, When and How of Getting Published. Participating will be Kelly Wainken, of John Marshall Law School Library who has recently completed a marketing study of 157 legal periodicals. Ms. Wainken will summarize her survey's results on what these periodicals have been publishing in the past and what they intend to publish in the future. Then, Charles Dyer of University of Missouri-Kansas City Law Library, editor of Law Library Journal, will speak on new directions in which Law Library Journal is developing. Next, Morris L. Cohen of Yale University Law Library will add an historical perspective on publishing--where it has come from and where it has evolved to presently. Finally, Sidney Bernstein, Assistant to the President of Matthew Bender Company, will add the publishers' point of view. Mr. Bernstein, who has also worked for Lawyers Cooperative Publishing Company, is a noted legal author, a member of the American Law Institute and is a former president of Scribes, the American Society of Legal Writers. Our very able program chairman, Kathleen Carrick, will be moderator for this panel discussion which will be at 10:00 A.M. on Wednesday, June 29.

On Tuesday, June 28, 7:00 - 9:00 P.M., there will be an evening discussion program chaired by John Hasko of University of Southern California Law Library. Types of materials used throughout the country in the teaching of WESTLAW/LEXIS databases will be discussed. Ideas from publishers' representatives and law librarians who use both systems will be presented.

We hope that all members of our Academic Libraries SIS who are at the convention will attend these programs.

EARLY MORNING MEETING

The Academic Libraries SIS meeting will be held on Monday, June 27, 1983, 7:00 - 9:00 A.M. in the Hyatt Regency, Arboretum 5. We will announce the election results, discuss this year's accomplishments and future projects. One idea we would like to consider is the possibility of the formulation of an AALL policy statement on faculty status and tenure for law librarians other than Directors.

Please make every effort to attend and bring your suggestions for projects for our SIS.
