### DATABASE PROFILE: HEIN ONLINE-NOW AVAILABLE REMOTELY FOR MEMBERS

The Law Library Association of St. Louis has been providing access to online legal research databases to members since 2012. This includes Westlaw Next as well as other electronic resources.

One resource available to members is HeinOnline. HeinOnline provides full text access to law review/law journal articles from the historical to the current, as well as legal periodicals, regulations, statutes and treatises. New materials always are being added to the collection.

***Starting December 1, HeinOnline will be available both in the library and through remote access to all Law Library members and member firms.*** Members will be receiving information shortly about how to access this database through the new Members Only page of the library website.
