Purpose:

- The grant will fund one or more projects of value to those professions that create, disseminate, or use legal and law-related information. The AALL Research Grant program aims to stimulate a diverse range of scholarship in any format.
- One or more grants totalling \$5,000.00 will be awarded by the AALL Research and Publications Committee provided the application(s) is judged worthy of support by the committee under the rules and guidelines established herein.
- Areas for potential research may include, but are not limited to, those described in the Association's Research Agenda.

Eligibility:

- Applicants should have experience with research projects, and an understanding of the creation, dissemination and/or use of legal and law related information. Applicants may be individuals or partnerships.
- Preference will be given to members of AALL, working individually or in partnership with others.
- Applicant(s) must provide a resume and statement of their qualifications for carrying out this project. AALL reserves the right to request additional supporting documents.
- Applicant(s) currently working on an AALL Research Grant of any type is not eligible to apply for another research grant until the previously awarded grant is judged completed by the AALL Research and Publications Committee.
- Participation in this AALL research project shall not be denied to any applicant or abridged on account of race, color, religion, gender, age, national origin, disability or sexual orientation.

The American Association of Law Libraries will award research grants twice year. The due dates for applications are April 1 and December 1.
