2023 EXECUTIVE BOARD CANDIDATES

Last week, AALL released an [eBriefing](#) announcing the 2023 slate of candidates for various positions on the AALL Executive Board. Members will vote for **one candidate to serve as vice president/president-elect (2024-2025) and two candidates to serve as Executive Board members (2024-2027)**. The president-elect will serve on the Board for three years (as vice president, president, and immediate past president) until July 2027. The election will be held October 1 to October 31, and elected candidates will begin their terms in July 2024. Results will be announced once all candidates have been informed.
