Liebert, whose term as president officially began at the conclusion of the Association’s July 15-18 Annual Meeting & Conference in Boston, is currently the director of information services at O’Melveny & Myers LLP. Liebert was elected by her fellow AALL members.

As President of AALL, Liebert remains steadfast in championing the critical role of law librarians and legal information professionals in law schools, law firms, and in government entities. Recognizing the profound impact of Artificial Intelligence (AI) and legal technology on legal research, information management, and library services, one of Liebert’s goals as the Association’s president is to empower members to embrace these innovations and continue leading progress within their respective organizations.

As the first female Asian-American President of AALL, Liebert is also committed to fostering, cultivating, and preserving a culture of diversity, equity, and inclusion in the Association and in the profession. This means recognizing that our greatest asset lies in our understanding of the broad range of members, partners, and stakeholders the Association represents.

“Legal information professionals are at the forefront of innovation and are invaluable partners in the pursuit of knowledge and justice for our institutions and the people we serve,” said Liebert. “As someone with a background in technology, I am particularly excited to see how AI will change and possibly revolutionize the way we work. AALL remains committed to providing the tools our members need to continue leading this transformation.”

An AALL member for 29 years, Liebert served as chair of the Appointments Committee and Executive Board Strategic Directions Committee, and as a member of the Executive Board Finance & Budget Committee. She also served as chair of the Annual Meeting Program Committee, and as an Executive Board member from 2018-2021.

Liebert is a 2021 Fastcase 50 award honoree and a frequent speaker on topics including technology, data, and library management. She was recently named a Fellow-Elect of the College of Law Practice Management and serves as the immediate past co-chair of the Indiana University Luddy School of Informatics, Computing, and Engineering Alumni Board. Her extensive background in both IT and information management comes from her work as a chief information officer, library and information governance director, law professor, and legal technology consultant.

She received her BS in Management from Case Western Reserve University and her MLS and JD from Indiana University Bloomington. She currently resides in Los Angeles, California, and enjoys playing the violin in a community orchestra with her daughter.
